Eligibility Criteria

As of 15th February 2024, candidates must:

Be age 45 years or younger;

Have their activities based in Asian countries;

Have made a substantial contribution to research and technological developments in chemical

engineering; and,

Be nominated either by a member of SCEJ, or the president / representative of a chemical

engineering-related academic society in an Asian country. N.B. 1), 2)

N.B.: 1) The board members of SCEJ and members of The Awards Committee are not

allowed to nominate any candidates.

2) Both a regular member of SCEJ and an academic society can nominate one candidate.

Submission Procedures

The nomination period for the Award starts from January 2024 and closes on 15th February 2024.

2. Nominators are asked to complete Annex 1, which has to be submitted to SCEJ by 15th

February 2024. In case of electronic submission, a PDF file and a WORD file each with the

nominator's signature will be required.

Annex 1 includes:

a. Nomination Form and,

- b. The recommendation letter of either a regular member of SCEJ (including international regular member), the president of the society of chemical engineering in other Asian countries or the representative of chemical-engineering-related society.
- 3. Nominees are required to complete Annex 2, which has to be submitted together with the materials designated therein to SCEJ by 15th March 2024. In case of submission by electronic files, Annex 2 has to be provided in two formats, i.e., a Word file and a PDF file.

Annex 2 includes:

- a. Nominee's Curriculum Vitae and,
- b. The nominee's five most significant articles written in English, including scientific papers or patent applications in the field of chemical engineering. In case of electronic submission, such articles have to be provided in PDF formats.

Selection Schedule and Post-Award Programs

- 1. The applied data will be thoroughly reviewed by The SCEJ Awards Committee for the period from March to July 2024.
- 2. Recipients of the Award will be notified no later than the end of July 2024.
- 3. Each of the Award winners is required to attend the commendation ceremony of the Award and to give an award-commemorative lecture at the International Chemical Engineering Symposia (IChES2025) / the 90th Annual Meeting of SCEJ to be held in Japan in the middle of March 2025; and, to contribute a journal review which will be peer-reviewed and published on The Journal of Chemical Engineering of Japan. The recipients' accommodation expenses and registration fees to attend the above meetings will be paid by SCEJ.
