## Eligibility Criteria\*

As of 14th February 2021, candidates must:

- Be age 45 years or younger;
- Have their activities based in Asian countries;
- Have made a substantial contribution to research and technological developments in chemical engineering; and
- Be nominated either by a member of SCEJ, or the president/ a representative of a chemical engineering related academic society in an Asian country.\*\*
- Will be required to present award lectures at the International Chemical Engineering Symposia (IChES2022)/ the 87<sup>th</sup> Annual Meeting of SCEJ to be held in Osaka or Tokyo, Japan, in the middle of March, 2022.
- \* Board members of the SCEJ and members of the Awards Committee are not allowed to nominate any candidates
- \*\* Both a regular member of the SCEJ and an academic society can nominate one candidate.

## **Submission Procedures**

The nomination period for the Award opens in early January of 2021 and closes on 14<sup>th</sup> February, 2021. Please use the following procedures:
